The dates are August 16, 17, 18, 19 2010

The 32-hour program is offered throughout the year in four eight-hour modules and for the first time after many requests this program will be held on **FOUR CONSECUTIVE DAYS** from 8:00am to 4:00pm. Classes for Program 26 will be held at the **Northern Illinois University-Hoffman Estates Campus, 5555 Trillium Blvd, Hoffman Estates, IL**. All modules must be completed within a twelve month period. The cost of the program **is \$750.00 per participant for IPPFA members and \$1,000.00 for non-members** and includes all instructions, a notebook, all textbooks, and related handout material. A \$25.00 reassignment fee will be assessed for each missed module. The Illinois Department of Insurance has approved this fee as a "necessary pension fund expense" under the Illinois Pension Code.

All Article 3 & 4 Pension Trustees elected or appointed AFTER August 13, 2009 are required to attend a 32-hour trustee certification course within 18 months of election or appointment to the board.
