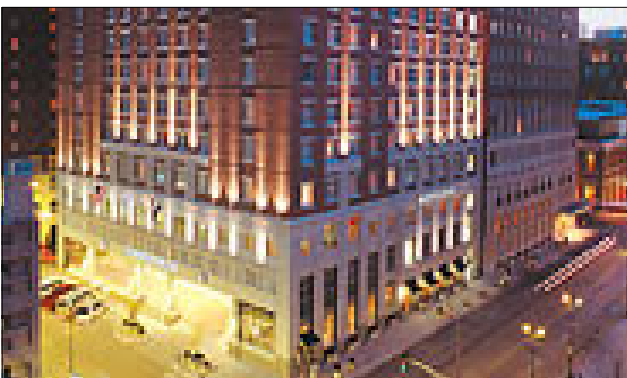
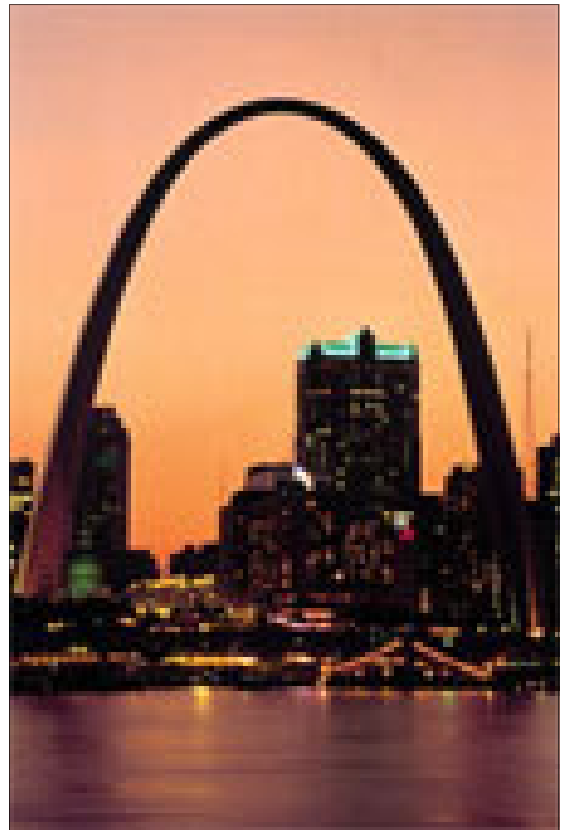

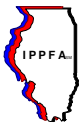
St. Louis is easily accessible by car, flying into nearby Lambert Airport or by Amtrak
