## A Message from IPPFA President, James McNamee

## Transfer Opportunity "Windows" Now Open



The recently passed Public Act 104-0284 provides an opportunity for some transfers of service within the "Downstate" Police and Fire pension systems as well as from Article 3 Police over to IMRF/SLEP. The information below is based on IPPFA's reading of the new law and bulletins from the Illinois Commission on Government Forecasting and Accountability (COGFA). Please refer any questions to your pension fund attorney and/or your fund's professional pension administration firm if you contract for this service.

The law opens "windows" for transfer of service between the two Downstate funds and also for Police to IMRF. The allowance for transfer expires February 15, 2026.

The phrase "windows" does not appear in the law but this is a good descriptor for the limited time periods during which

transfers can be made. It is IPPFA's position that these limited opportunities are a poor mechanism for pension service accrual and transfer. These opportunities should either be made permanent *or* Article 3 and Article 4 Downstate systems should be admitted to the list of pension funds covered under the *Illinois Reciprocal Act*. If you agree, let your state legislators know.

The new opportunities are:

Six Month Window for Downstate Fire Members to Transfer Service Credit from a Downstate Police Fund. There is no permanent transfer opportunity between the Downstate Police and Downstate Fire pension funds. Previously P.A. 102-0063 opened a 6-month window in 2021 to allow a Downstate firefighter to transfer up to 8 years of credit from a Downstate Police pension fund to a Downstate Fire pension fund. The new P.A. 102-0284 opens an identical window that expires February 15, 2026.

Under the new law, the police pension fund must pay to the fire pension fund an amount equal to:

- 1) The amounts accumulated to the credit of the applicant on the date of transfer of service credit;
- 2) Employer contributions in an amount equal to the amount previously stated in item 1, and;
- 3) Any interest paid by the applicant in order to reinstate service in the Downstate

Police fund.

## Six Month Window for Downstate Police Fund Members to Transfer Service Credit from a Downstate Fire Fund.


P.A. 102-0284 creates a new service credit transfer window, permitting active Downstate Police members to transfer up to 8 years of service credit from a Downstate Fire pension fund. An applicant must pay the difference between their past contributions (employee contributions, employer contributions & accumulated interest), and the amount they would have contributed to the Downstate Police fund for the equivalent service credits, as determined by the Downstate Police pension fund board. This law is now effective and the opportunity expires on February 15, 2026.

#### Six-Month Window for Downstate Police to Transfer Service Credit to IMRF.

Under prior law there was no reciprocity between Downstate Police pension funds and IMRF. A previous transfer window created by P.A. 102-1061 had allowed for the transfer of 10 years of service credit from Downstate Police to IMRF SLEP in 2022. Applicants were required to pay the difference between their employer and employee contributions from Downstate Police, and the equivalent contributions plus interest at IMRF's actuarially assumed rate.

P.A. 104-0284 reopens this transfer window for six months from the effective date of the bill, without a cap on the amount of service credits transferred. We believe the deadline will be February 15, 2026. An applicant transfers along with their service credit their employee contributions, employer contributions and any applicable interest that shall be determined by IMRF. Should there be a difference between the amount transferred from Downstate Police and the IMRF-determined contributions for the equivalent amount of service credit, the applicant is given the option of making up the difference or accepting a lower amount of service credit.

Freeport Fire Department End of Watch: November 12, 2013

The Heroes Family Fund is proud to honor the memory of Firefighter Daniel J.

Bower, whose life and service continue to inspire those who wear the uniform today.

Firefighter Dan Bower dedicated his life to serving others. He began his career with the City of Freeport Fire Department on August 29, 2002, and quickly earned the respect and admiration of his peers for his professionalism, compassion, and tireless work ethic. Throughout his career, Dan served as both a firefighter and paramedic, a member of the Hazardous Materials Team, and the MABAS 17 Technical Rescue Team. He also shared his expertise as a Confined Space Instructor with the Illinois Fire Service Institute, helping to train and protect fellow firefighters across the state.

Beyond his daily duties, Dan's leadership extended to the Associated Fire Fighters of Illinois (AFFI) Honor Guard, where he served as the District 7 Commander. His deep sense of duty, humility, and honor left an indelible mark on everyone who had the privilege to serve beside him.

Dan passed away in the line of duty on November 12, 2013, at the age of 38, after a courageous battle with cancer. Though gone too soon, his legacy of bravery, mentorship, and selflessness continues to shine brightly within the fire service community.

In recognition of his unwavering commitment, the AFFI Honor Guard established the Daniel J. Bower Commitment to Excellence Award. First introduced at the 21st Annual AFFI Honor Guard Convention in February 2013, the award was officially renamed and dedicated in Dan's honor at the 22nd Annual Convention on January 26, 2014. The award is presented to one individual who embodies the Honor Guard's motto "Whatever It Takes" and demonstrates a level of commitment and dedication above and beyond the call of duty.

This meaningful tribute ensures that Dan's spirit lives on through others who, like him, understand that the purpose of the Honor Guard and the fire service itself is bigger than any one individual.

Firefighter Daniel J. Bower's life serves as a powerful reminder of what it truly means to serve with courage, compassion, and integrity. His legacy continues to inspire the firefighting family across Illinois and beyond.
